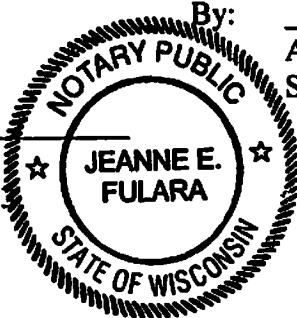


EXHIBIT A

LEGAL DESCRIPTION

That part of the Southwest One-quarter (1/4) of Section Thirteen (13), in Township Eight (8) North, Range Twenty-one (21) East, in the City of Milwaukee, Milwaukee County, Wisconsin, bounded and described as follows: Commencing at the Southwest corner of said ¼ Section; thence East along the South line of said ¼ Section 1710.50 feet to its intersection with the East line extended South of North 38th Street; thence North 00°58'00" East along the East line of North 38th Street and its extension South and parallel to the West line of said ¼ Section 863.61 feet to a point in the center line of West Clinton Avenue; thence due East along the center line of West Clinton Avenue, 220.33 feet to the point of beginning of the land to be described; thence due East and parallel to the South line of said ¼ Section along the center line of West Clinton Avenue, 138.85 feet to a point in the Westerly line of North Teutonia Avenue; thence South 14°06'30" East along the Westerly line of North Teutonia Avenue, 173.67 feet to a point; thence due West and parallel to the South line of said ¼ Section 138.85 feet to a point in the Easterly line of Clinton Manor, being a part of the Southwest ¼ of Section 13, Township 8 North, Range 21 East; thence North 14°06'30" West along the Easterly line of Clinton Manor, 173.67 feet to the place of beginning. Reserving the North 30 00 feet for West Clinton Avenue.
