

For twenty-seven years Howe worked at the side of Frank Lloyd Wright, directing activities of his drafting room and as one of the first members of the Taliesin Fellowship he was well schooled in the principals of organic architecture. This is the last and largest home designed by the acclaimed architect John H. Howe.

## LOCATION

Just 35 minutes from Madison, but a world away in Sauk County. Freedom Ridge Estate is perched atop a ridge with commanding 40-mile views, minutes from the Sauk County Airport, Lake Wisconsin, The Dells, Baraboo, an 8,000 acre nature conservancy forest, and all of the year around activities this area is known for.
